**Access the latest technology.** As Infor's strategic upgrade for the Infor ERP PRMS solution, Infor ERP LX features a browser-based, user interface for easy access from anywhere, anytime. Infor ERP LX Electronic Commerce Manager and the LX Connector enable communication in and out of ERP LX while ensuring appropriate business process and data-validity checking. Designed to take full advantage of Infor Open SOA, Infor's approach to service-oriented architecture, Infor ERP LX will deliver SOA components that make it possible to add new functionality without requiring a major upgrade. Infor Open SOA also makes it easy to integrate complementary applications such as Warehouse Management and Enterprise Asset Management with Infor ERP LX.

**Streamline manufacturing and planning.** Infor ERP LX Manufacturing Data Management includes full engineering change control capabilities. Users can apply engineering change control by individual item and/or facility if global engineering change control is not desired. Engineering change implementation can be controlled based on traditional date effectivity, by the parent or component on-hand balance, or the comparison of the on-hand balance and a minimum balance. This capability makes possible the reservation of service and repair parts for field upgrades and/or warranty coverage. Finally, engineering change orders may be facility and/or method-code specific to satisfy the most robust engineering change order requirements.

Infor ERP LX supports lean manufacturing initiatives so your company can reduce inventory, improve order promising, shorten order cycle times, and eliminate other non value-added activities. There are comprehensive capabilities for scheduling; manufacturing campaign management; repetitive, project and just-in-time (JIT) manufacturing in addition to traditional shop order processing for true mixed-mode manufacturing capabilities within the same environment.

**Leverage robust supply chain capabilities.** To provide world-class customer service, Infor ERP LX translates customer requirements into orders and integrates them into the planning, operations, and execution systems within the enterprise. Infor ERP LX determines prices based on list prices, special prices, promotions and deals, and user-override prices. With Infor ERP LX, only one special price applies to an order line or order. The promotions and deals capability keeps track of the amount and quantity of sales, as well as the amount and quantity of invoice activity tied to a promotion. In addition, promotions can be cumulatively applied or stacked. All pricing is date sensitive and supports multiple currencies.

Infor ERP LX features a Trade Funds Management module to plan, control, and track spending related to marketing of products and business operations. The process includes development of a plan for spending funds, commitments of funds, tracking of those funds, and payment settlements. As certain expenses are accrued, they are registered as liabilities within the ledger. Trade funds are tracked through two areas of the business—sales spend and trade spend.

With the introduction of inbound logistics management and outbound logistics management, organizations using Infor ERP LX will have visibility of their entire supply chain. Delivery processing in inbound logistics management allows transportation planning and landed cost calculation for all inbound materials, domestic and import. Outbound logistics management supports the planning, costing, and optional customer billing of freight on all outbound goods.

**Enhance financial management.** Infor ERP LX delivers a range of capabilities that enable organizations to focus on global opportunities without diminishing their ability to execute at the local level. To help customers with international operations meet ever expanding financial, tax, and statutory requirements, Infor ERP LX makes information about cash flow, budgets, taxes, currency positions creditors, and vendors readily available to the financial organization. Infor ERP LX Configurable Enterprise Accounting translates and consolidates critical financial information in all currencies, across all regions and time zones, and conforms to multiple accounting standards.

The Accounts Payable module provides tools for controlling invoices, processing payments, and optimizing cash flow. The module supports a two-way, three-way or four-way match process to confirm quantities, prices, receipts, inspection information and invoices. It offers multi-company, currency, payment method, and tax processing support.

Providing complete on-line access to a customer's credit line, payment history, aged open receivables, and critical information such as days sales outstanding and average days to pay, organizations can improve credit, collection, and receivable operations through effective processing and controls.

Seamless integration to other Infor ERP LX modules ensures that a complete flow of detail transaction information is available to accounts receivable for the application of incoming funds. Order management tracks a customer's available credit and automatically highlights credit exposure, providing the ability to hold or approve orders based on user-defined limits. Additionally, credit memos, debit memos, and authorized deductions flow from billing and sales analysis, and promotions, deals and pricing through to accounts receivable.

Credit exposure is minimized with complete on-line credit exception reporting, user-defined account aging, payment, and sales history, and extensive note capabilities based on either note types or free-form notes, dispute codes, and action dates at the invoice and customer level. Credit and Deduction Management provides powerful capabilities to identify, track, and resolve deductions efficiently.

Advanced remittance processing allows for high-volume batch processing of payments. Cash batches originate from a variety of standard electronic commerce transmissions. Identifiers like the magnetic ink character recognition (MICR) number from the check, invoice number, and amount are used to target the application of payments to the appropriate account and individual items. As with online cash application, terms, discounts, taxation, and currencies are automatically handled. Activities related to cash transmission batches are summarized and available on-line for selection by staff for additional work and management review.



**Strengthen regulatory compliance and security.** Security capabilities have been enhanced for all major transactional subsystems at the appropriate level in the company, facility, and warehouse hierarchy. The configurable ledger allows for proper statutory reporting.

**Support global operations.** Infor ERP LX supports global business requirements across financials, manufacturing, and the supply chain to help companies optimize internal and external processes. The efficiency of global operations is facilitated by the multi-company and multi-facility capabilities, including multi-language and multi-currency functions, and the ability to convert transaction dates to the appropriate time zone based on the user, company, facility, warehouse, vendor, or customer.

**Lower total cost of quality.** Infor ERP LX features fully integrated quality management to manage, capture, and track quality information throughout the manufacturing and supply chain processes. The module assures that strict tolerances for variable attributes are managed, reported, and measured throughout the supply chain. This minimizes re-work, waste, and other costs.
